## First Responder Course

First Responders are often the first trained person to arrive at the scene of an emergency. You will be expected to take appropriate action and provide care for injuries or sudden illness until more advanced medical personnel arrive. This course prepares you to fulfill this role as a First Responder. Students will practice basic skills in small groups.

This course should be taken by Police Officers, Firefighters, Rescuers, Office of Emergency Management Personnel, Recreation Coaches, Teachers, and any other persons who wish to be prepared.

This 48 hour course starts on Monday, January 31, 2011. Classes will be held Monday & Wednesday evenings from 7:30 to 10:30 PM. The last night of class is Wednesday, March 23, 2011.
